

1. Introduction – Basic information about the survey

1.1 Purpose, goal and subject of the survey

The aim of the survey is to present the data on number of issued building permits and works registered, as well as number and area of dwellings in buildings for which construction permits and works registered are issued.

1.2 Legal basics

The Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12, 47/19) defines provisions for the collection, processing, and dissemination of data. The Law provides to the Statistical Office legal powers to collect and access the data necessary for the implementation of Programme and Annual Plan. The Law gives a priority to the use of administrative data and right of access to individual data that are a result of survey of other official statistical producers. As an annex to legal provisions, Statistical Office has signed several memoranda on cooperation with administrative data providers.

EU regulations defining this area of statistics:

- 1) REGULATION (EU) 2019/2152 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 November 2019 on European business statistics.
- 2) COMMISSION IMPLEMENTING REGULATION (EU) 2020/1197 of 30 July 2020 laying down technical specifications and arrangements pursuant to Regulation (EU) 2019/2152 of the European Parliament and the Council on European business statistics.

1.3 Statistical units

Observation unit is Ministry of Ecology, Spatial Planning and Urbanism who according to the Law on Spatial Planning and Construction of Buildings ("Official Gazette of Montenegro" No. 064/17 dated 6 October 2017) issued a building permits and notification of building work.

1.4 Coverage and scope of survey

1.4.1 Sectors

The source of data are Ministry of Ecology, Spatial Planning and Urbanism.

1.6 Concepts and definitions

Building permits and notification of building permits is usually defined as a permit issued upon request that generally performs the work on the construction project as planned.



Number of building permits, notification of building work and the date of issuance of building permits are the number and date of issuance of building permits issued for the facility to which the application relates to starting work. Investor – is the person for whose benefit the facility is constructed, respectively a person who finances the construction of the building and on whose behalf the issuance of construction permits.

4. Timeliness and punctuality

4.1 Timeliness

Preliminary data are published 55 days after the end of the reference period. The final data are published 4 months after the completed reference period.



Time lag of the first results

The indicator of the timeliness of publication of preliminary data represents the time between the date of the last day of the reference period and the date of publication of the first data. The preliminary data are published 55 days after the completed reference period. The deadlines for the publication of preliminary data on building permits and notification of building work in 2023 have been met in accordance with the Statistical Release Calendar.

Time lag of the final results

The timeliness indicator of the publication of the final data represents the time between the date of the last day of the reference period and the date of publication of the final data. The final data are published 4 months after the completed reference period. The deadlines for the publication of final data on building permits and notification of building work in 2023 have been met in accordance with the Statistical Release Calendar.

4.2 Punctuality

The punctuality indicator represents the time difference between the actual publication of the data and the planned publication of the data. Deadlines of dissemination of building permits and notification of building work data are defined in the Statistical Release Calendar and these deadlines are respected.

Indicator TP3 (punctuality) is 0, i.e. no difference between the actual publication of the data and the planned publication of the data, which means that the Releases are published according to the deadlines which are defined in the Statistical Release Calendar.

5.1 Statistical Release Calendar

The Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12 and 47/19.) stipulates that official statistical producers prepare, update, and publish the Statistical Release Calendar. It is published on the website of Statistical Office not later than 20 December for the next year, for all official statistical producers that includes date of releasing statistical data. Any change in date of release in the Calendar is published in advance in accordance with the Procedure on Unplanned Revisions.

The Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12 and 47/19) regulates rules under which external users can obtain an access to individual data for needs of research. Article 58 defines types of scientific and research organizations that can obtain such data. Providing individual data without identifiers is possible only upon a written request of scientific and research institutions, with the purpose of performing scientific and research activities as well as international statistical organizations and statistical producers from other countries. The research entity signs the agreement with the Statistical Office, and it signs the statement on respecting the confidentiality principle. Official statistical producers keep separate records on users and the purpose of using the statistical data given to these users.
