Entrance of row cows' milk and products obtained in dairies

First quarter 2023¹

The total quantity of purchased cows' milk, by dairies in the territory of Montenegro in the first quarter of 2023 is 6 499 796 kg, and shows an increase of 10.7% compared to the same quarter of 2022.

The average content milk fat in the first quarter of 2023, compared to the first quarter of 2022, recorded an increase of 6.5%, while the protein content recorded an increase of 3.2%.

In the first quarter of 2023, compared to the same quarter of 2022, was recorded an increase in the production of drinking milk (by 2.8%), cream (by 7.7%), fermented milk products (by 4.1%), traditional butter (by 14.4%), and other yellow products (by 155.3%), while cheese production recorded an increase of 0.2%.

METODOLOGICAL NOTES

Legal basis

The survey's is conducted on the basis of the Law on Official Statistics and Official Statistical System of Montenegro (Official Gazette of Montenegro 18/12, and 47/19). The collected data is protected in accordance with the Law on Official Statistics and Official Statistical System of Montenegro (Article 34, 55 and 56).

Purpose and content of survey

The survey collects the data about the entrance of cows' milk and manufactured products, with monthly periodicity data collecting. Data on total milk quantites collected from farms, exclude import.

Reporting units

Reporting units are dairies in the territory of Montenegro.

Method and time of collection

Data are collected through reporting method. Administrative data control conducted with cooperation with Ministry of Agriculture, Forestry and Water Management. The periodicity is monthly. Reporting units are obliged to send data to the Statistical Office – MONSTAT, up to 10th of the current month for the previous month (Monthly survey).

Definition

Definitions are in accordance with the regulations and the Decision of Eurostat (Commission Decision No 97/80EC, Annex 1).

Data representativeness

Data are representative on the level of Montenegro.

Data are published according to the Statistical Release Calendar.

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
