Obuhvat

Obuhvat se temelji na Regulativi EU br. 2019/2152 za kratkoročne statistike. Ukupan promet u uslužnim djelatnostima obuhvata promet u sljedećim djelatnostima Klasifikacije djelatnosti (KD 2010): G_X_G47 - Trgovini na veliko i malo motornim vozilima i motociklima (bez oblasti G47 Trgovina na malo); H - Saobraćaj i skladištenje; I - Usluge smještaja i ishrane; J - Informisanje i komunikacije; M_X_M701,721,722,750 - Stručne, naučne i tehničke djelatnosti (bez grana M701, M721, M722 i M750); N_X_N771,772,773,774,811,813 - Administrativne i pomoćne uslužne djelatnosti (bez grana N771, N772, N773, N774, N811, N813).

Definicije

Promet bez PDV-a je vrijednost ukupnog prometa koji je preuzeće ostvarilo u toku izveštajnog kvartala na teritoriji Crne Gore i iskazuje se u eurima. Obuhvata se ukupan promet koji je preuzeće ostvarilo, bez obzira da li je ostvaren u nekoj drugoj djelatnosti. Obrađuje se vrijednost prometa bez PDV-a u izveštajnom kvartalu.

OTHER SERVICES

Sources of data

The survey is based on an administrative data source - Tax Administration of Montenegro. The units of observation are companies in Montenegro who submitted VAT registration to the Tax Administration.

Coverage

Coverage is based on EU Regulation No 2019/2152 for short-term statistics. Total turnover in service activities includes turnover in the following activities Classification of Activities (NACE Rev. 2): G_X_G47 - Wholesale and retail trade in motor vehicles and motorcycles (excluding G47 Retail); H - Traffic and storage; I - Accommodation and food services; J - Information and communication; M_X_M701,721,722,750 - Professional, scientific and technical activities (without branches M701, M721, M722 and M750); N_X_N771,772,773,774,811,813 - Administrative and support service activities (without branches N771, N772, N773, N774, N811, N813).

Definitions

The turnover excluding VAT is the value of the total turnover that the enterprise realized during the reporting quarter on the territory of Montenegro and is presented in EUR. It covers the total turnover that the company has achieved, regardless of whether it has been realized in any other activity. Value of turnover excluding VAT in the reporting quarter is processed.
