# Number and structure of business entities in Montenegro

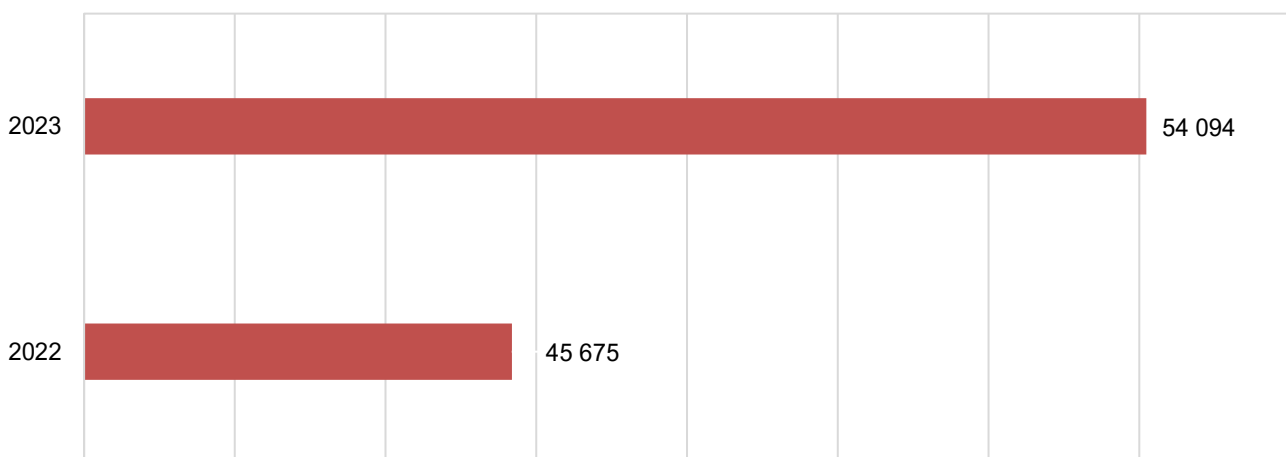

## 2023

The number of business entities in Montenegro in 2023 was 54 094, which compared to 2022 when there were 45 675, expressed in percentage, represents an increase of 18.4%.

The largest number of active business entities in 2023 is in Podgorica 18 593, which represents 34.4% of the total number, and the smallest is in municipality of Gusinje 40 or 0.1% of the total number of active business entities.

## STRUCTURE OF BUSINESS ENTITIES

The structure of business entities can be observed on several bases, by type of ownership, section, and size class.

### *By type of ownership*

The Statistical Business Register used for this analysis recognized three type of ownership: private, two or more type of ownership and state ownership. According to the type of ownership, out of the total number of business entities in Montenegro, 99.5% is privately owned. The same situation was recorded in the previous year.

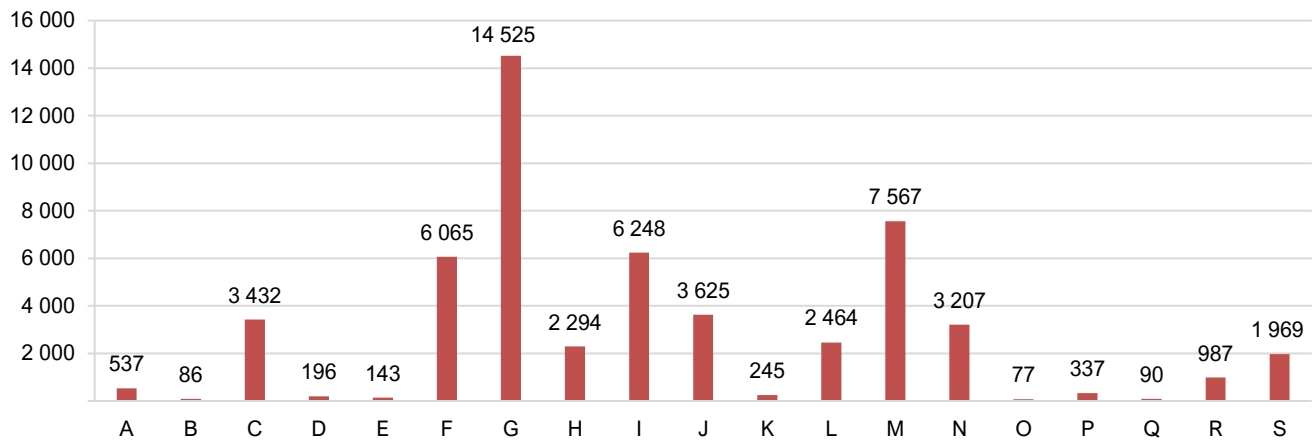
**By sections**

The largest number of active business entities in 2023 is in „Wholesale and retail trade, repair of motor vehicles and motorcycles” 14 525 which represents 26.9% of the total number.

To classify a business entity by size, the annual cross-section of employment is used, not employment on a specific date.

Table 4 shows the number of small, medium, and large enterprises in 2022 and 2023. In Montenegro, small companies are the most represented, accounting 99.3 % of the total number of active business entities in 2023.

## METHODOLOGICAL NOTES

### Importance and demands for Statistical Business Register (SBR)

Importance and demands for Statistical Business Register (SBR) The Decree of Government of the Republic of Montenegro No 02-164 (Official Gazette of the Republic of Montenegro 4/01) created preconditions for the introduction of SBR in the statistical system of our country, and in accordance with the demand for harmonization of our country statistical system with statistical systems of the EU member countries, since SBR is an important segment in the system of statistical surveys (to achieve the satisfying level of statistical compliance and comparability. It is necessary to have a certain register standard, and thus the Council Regulation (EEC) No 2186/93 of 22 July 1993 on Community coordination in drawing up business registers for statistical purposes was adopted.

Statistical business register is a reliable data source on business population and demography. It serves as a sample frame for all surveys on business statistics within national statistical system; it provides a base from which the address data are used for sending statistical survey questionnaires, etc. As such, the register is considered as a system for the transfer of data from administrative sources into the data appropriate for statistical use. Another importance of SBR is reflected in the fact that SBR is an updated dossier covering any statistical unit active in Montenegro which achieves turnover, and possesses relevant statistical and administrative attributes.

### SBR objectives

Main objectives of existence of SBR are to cover national economic activities as much as possible, to help in improving the efficiency of national statistical system, and to serve as the main data source for a large number of statistical surveys within national statistical system.

### SBR principles

According to established objectives, SBR is projected on the basis of main principles of confidentiality, coherence, timeliness and cost-effectiveness.

### Subject of SBR

The subject of this register are active business entities that in the observed year, perform a specific activity, have employees and achieve a certain turnover.

### SBR sources

Data sources for updating SBR are divided in external and internal sources. External sources are administrative (Tax Administration, Central Register of Business Entities, Central Bank, and business and professional associations) while internal sources are statistical surveys used for both updating this register, and comparable analyses with administrative data. Size class is defined on the basis of three criteria:

- Number of employees,
- Turnover, and
- Assets.

Legal entities, in terms of the Law on Accounting and Auditing (Official Gazette of Montenegro No 052/16 of 09.08.2016), are classified into small, medium and large, depending on the average number of employees, total annual income level, and total assets.
