Preliminary data

Turnover Indices of **Retail Trade**

Fourth quarter 2023

Turnover of goods in retail trade in IV guarter 2023, compared to IV guarter 2022, increased by 6.8% in current and 2.5% in constant prices.

Turnover of goods in retail trade in IV quarter 2023, compared to III quarter 2023, decreased by 21.0% in current and 20.8% in constant prices.


Retail trade in motor fuels in IV quarter 2023, compared to IV quarter 2022, decreased by 6.1%, while compared to III quarter 2023, it decreased by 27.2%.

Retail trade turnover of food in IV guarter 2023, compared to IV guarter 2022, increased by 4.2% at current, while compared to III quarter 2023, it decreased by 27.9%.

Retail trade of cosmetic and pharmaceutical products in IV quarter 2023 increased by 13.8% compared to IV quarter 2022, while it decreased by 3.2% compared to III quarter 2023.

Retail trade in other non-food products increased by 10.6% in IV quarter 2023, compared to IV quarter 2022, and decreased by 15.0% compared to III guarter 2023.

METHODOLOGICAL NOTES

Internal trade statistics covers and presents the turnover of companies with the retail trade as their main activity.

From January 2021, the survey is based on an administrative data source (Revenue and Customs Administration of Montenegro). Pursuant to the cooperation agreement concluded in Podgorica in September 2010 between the Statistical Office and the Revenue and Customs Administration, turnover data are submitted on the basis of VAT returns in electronic form.

The survey covers companies that are registered in area 47 according to the Classification of Activities (KD 2010).

Turnover of goods in retail trade represents the value of goods sold by the company that is sold to final consumers, i.e. the population for personal consumption and household use, as well as legal and natural persons to perform activities.

Indices of turnover of goods in constant prices are received by deflating index in current prices by appropriate indices of retail goods prices.

Data are published according to the <u>Statistical Release</u> Calendar.

The last published data are considered preliminary, and becomes final within the defined deadline, as foreseen by the Statistical Release Calendar.
