Turnover Indices of Retail Trade

First quarter 2024

Turnover of goods in retail trade in I quarter 2024 compared to I quarter 2023 increased by 11,1% in current and 6.9% in constant prices.


Turnover of goods in retail trade in I quarter 2024 compared to IV quarter 2023 decreased by 11.8% in current and 12.2% in constant prices.

Retail trade in motor fuels in I quarter 2024 compared to I quarter 2023 decreased by 2,8%, while compared to IV quarter 2023 it decreased by 17,9%.

Retail trade turnover of food in I quarter 2024 compared to I quarter 2023 increased by 10.3% at current, while compared to IV quarter 2023 it decreased by 8.7%.

Retail trade of cosmetic and pharmaceutical products in I quarter 2024 increased by 12.6% compared to I quarter 2023, while it decreased by 4.6% compared to IV quarter 2023.

Retail trade in other non-food products increased by 13.7% in I quarter 2024 compared to I quarter 2023, and decreased by 14,1% compared to IV quarter 2023.

METHODOLOGICAL NOTES

Internal trade statistics covers and presents turnover of companies with the retail trade as their main activity.

From January 2021, the survey is based on an administrative data source (Revenue and Customs Administration of Montenegro). Pursuant to the cooperation agreement concluded in Podgorica in September 2010 between the Statistical Office and the Revenue and Customs Administration, turnover data are submitted on the basis of VAT returns in electronic form.

The survey covers companies that are registered in area 47 according to the Classification of Activities (KD 2010).

Turnover of goods in retail trade represents the value of goods sold by the company that is sold to final consumers, ie the population for personal consumption and household use, as well as legal and natural persons to perform activities.

Indices of turnover of goods in constant prices are received by deflating index in current prices by appropriate indices of retail goods prices. Data are published according to the <u>Statistical Release</u> <u>Calendar</u>.

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
