Preliminary data

Turnover Index of **Retail Trade**

Third quarter 2024

Turnover of goods in retail trade in III guarter 2024, compared to III guarter 2023, increased by 8.4% in current, and 6.9% in constant prices.

Turnover of goods in retail trade in III quarter 2024, compared to II quarter 2024, increased by 21.8% in current, and 21.2% in constant prices.


Retail trade in motor fuels in III quarter 2024, compared to III quarter 2023, increased by 1.2%, while compared to II guarter 2024, it increased by 26.2%.

Retail trade turnover of food in III guarter 2024, compared to III guarter 2023, increased by 7.4%, while compared to II quarter 2024, it increased by 27.9%.

Retail trade of cosmetic and pharmaceutical products in III quarter 2024 increased by 9.3% compared to III quarter 2023, while it increased by 12.4% compared to II quarter 2024.

Retail trade in other non-food products increased by 10.2% in III quarter 2024 compared to III quarter 2023, and increased by 15.7% compared to II guarter 2024.

METHODOLOGICAL NOTES

Internal trade statistics covers and presents turnover of companies with the retail trade as their main activity.

The source of data for the implementation of the Turnover index in retail trade survey is turnover data from VAT returns (jurisdiction of the Tax Administration) on day 23 October 2024.

The survey covers companies that are registered in area 47 according to the Classification of Activities (KD 2010).

Turnover of goods in retail trade represents the value of goods sold by the company that is sold to final consumers, i.e. the population for personal consumption and household use, as well as legal and natural persons to perform activities.

Indices of turnover of goods in constant prices are received by deflating index in current prices by appropriate indices of retail goods prices.

Data are published according to the <u>Statistical Release</u> Calendar.

The last published data are considered preliminary, and becomes final within the defined deadline, as foreseen by the Statistical Release Calendar.
