
Average earnings (wages)

September 2022

The average earnings (gross) in Montenegro in September 2022 are 887 Euro, while the average earnings without taxes and contributions (net) are 718 Euro. Having in mind that consumer prices in September 2022 comparing to August 2022 increased for 1.4% the results is that real earnings without taxes and contributions (net) in the same period decreased for 1.4%.

The average earnings (gross) in the third quarter 2022 comparing to second quarter 2022 increased 1.3%.

At the sector level, the average earnings without taxes and contributions (net) in September 2022 compared to August 2022 increased in the following sectors: Real estate acitivities (4.1%), Transportation and storage (2.1%), Electricity, gas, steam and air conditioning supply (1.5%), Wholesale and retail trade and repair of motor vehicles and motorcycles (1.0%), Financial and insurance activities (0.9%), Other service activities (0.9%), Manufacturing (0.2%), Accommodation and food service activities (0.2%) and Mining and quarrying (0.1%).

There were a decrease in the following sectors: Human health and social work activities (1.1%), Administrative and support service activities (1.0%), Construction (0.7%), Information and communication (0.7%), Water supply, sewerage, waste management and remediation activities (0.6%), Education (0.6%), Professional, scientific and technical activities (0.5%), Arts, entertainment and recreation (0.5%), Public administration and defence; compulsory social security (0.4%) and Agriculture, forestry and fishing (0.3%).

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD–1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index. The data are released 30th in a month for the previous one.
