

Industrial production - PRODCOM 2017 ^(p)

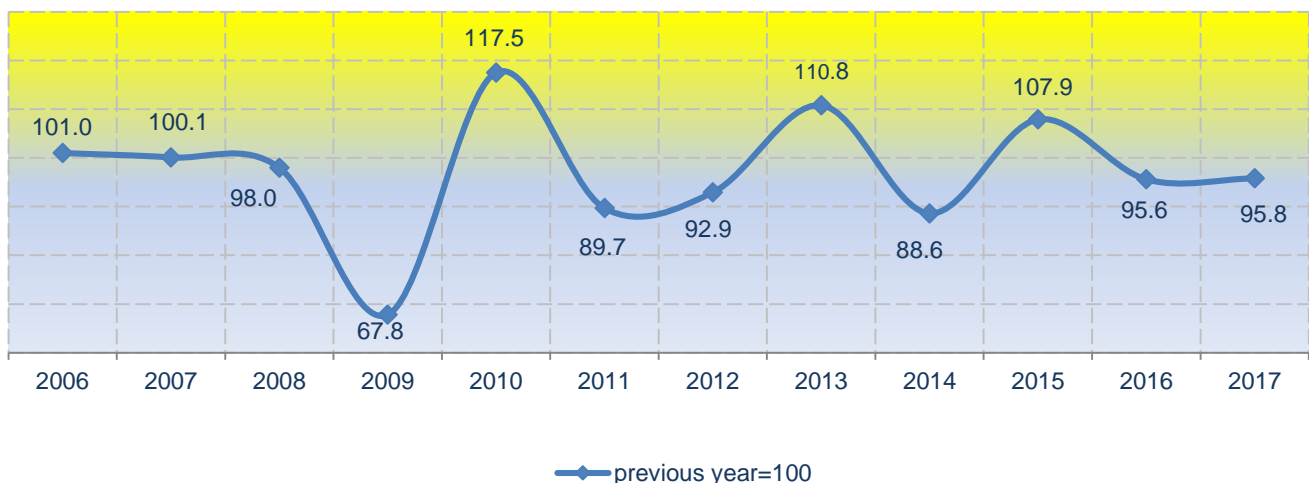
In 2017 the production of the following products increased compared with the production from 2016:

- Coniferous wood; sawn or chipped lengthwise from 92 911 m³ to 93 735 m³, i.e. 0.9%;
- Pre-coated aggregates from 78 626 t to 86 124 t, i.e. 9.5%;
- Ready-mixed concrete from 342 719 t to 719 301 t, i.e. 109.9%.

In 2017 there was a decrease of production among the following products when compared with the production from 2016:

- Wheat or meslin flour from 26 233 t to 11 850 t, i.e. -54.8%;
- Medicaments of penicillins, streptomycins or derivatives thereof from 316 980 kg to 195 915 kg, i.e. -38.2%;
- Ball bearings from 1 027 t to 994 t, i.e. -3.2%.

METHODOLOGICAL NOTES

Annual survey IND-21 collects the following data on industrial production: quantities of stocks at the beginning of the year; production realized (within that there are presented the data on produced quantities, and separately for service produced quantities); quantity spent for further manufacture; quantity at the end of year; quantity; and value of product sale. A separate list monitors purchase, expenditures, stocks of energy, and fuel for operating and technological purposes.

The reporting method is applied – Reporting units for industrial production are businesses engaged in the industrial production (sectors B and C of Activity Classification), as well as parts of commercial businesses classified into other sectors of Activity Classification, and they satisfy the criteria for this survey.

Every reporting unit drafts a report in the form (questionnaire) IND-21. Reporting units submit the Annual Report on Industry for previous year to the responsible regional unit, not later than 20 April of current year. The data sources are bookkeeping, warehouse records, and other records, and documentation available at the reporting unit.

From 2011, this survey was conducted according to current PRODCOM list, used as official nomenclature of industrial products.
