**POLJOPRIVREDA****Agromonetarna statistika****Izvori podataka**

Podaci o prodaji i otkupu proizvoda poljoprivrede, šumarstva i ribarstva prikupljaju se mjesečnim izvještajima o realizaciji poljoprivrednih proizvoda sopstvene proizvodnje poljoprivrednih preduzeća i zemljoradničkih zadruga i mjesečnim izvještajem o otkupu poljoprivrednih proizvoda od individualnih gazdinstava.

**Obuhvatnost**

Mjesečnim izvještajima o prodaji i otkupu proizvoda poljoprivrede, šumarstva i ribarstva obuhvaćena su poljoprivredna preduzeća, zemljoradničke zadruge kao i druga preduzeća koja su ovlašćena da vrše otkup proizvoda od individualnih gazdinstava u cilju dalje prerade ili prodaje.

Kriterijum za obuhvat pravnih lica je broj radnika (od 2 i više zaposlena radnika).

**Definicije**

Podaci o prodaji i otkupu proizvoda poljoprivrede, šumarstva i ribarstva obuhvataju vrijednost prodaje proizvoda iz sopstvene proizvodnje preduzeća i zadruga kao i otkup vrijednosti proizvoda od individualnih gazdinstava, koje vrše zato ovlašćene organizacije u cilju dalje prerade ili prodaje.

**Osiguranici poljoprivrednici****Izvor podataka**

Zvanični proizvođač podataka o osiguranicima poljoprivrednicima je Uprava prihoda i carina. Kao izvor za dobijanje podataka o osiguranicima poljoprivrednicima služi postojeća evidencija Fonda PIO (za poljoprivrednike koji su se registrovali do juna 2004. godine) i Registar Ministarstvo poljoprivrede i ruralnog razvoja (koje vodi Registar osiguranika poljoprivrednika od 2004. godine). Administrativni izvor baze podataka je Uprava prihoda i carina. Za poljoprivrednike koji su se registrovali do juna 2004. godine (u Fondu PIO), odjava osiguranja se vrši na način što sam osiguranik podnosi obrazac JPR dodatak B i rješenje Fonda PIO o prestanku osiguranja nadležnoj područnoj jedinici Uprave prihoda i carina. Za osiguranike poljoprivrednike koji se vode u njihovom registru, Ministarstvo poljoprivrede, šumarstva i vodoprivrede dostavlja dokumentaciju o prijavi/odjavi Centrali Uprave prihoda i carina.

**Definicija osiguranika poljoprivrednika**

Osiguranici poljoprivrednici su lica koja se bave poljoprivrednom djelatnošću (poljoprivrednici, članovi domaćinstva poljoprivrednika i članovi mješovitog domaćinstva) kao jednim ili glavnim zanimanjem koji nijesu osiguranici zaposleni, osiguranici samostalnih djelatnosti, korisnici penzija, na školovanju i koji imaju opštu zdravstvenu sposobnost (Zakon o penzijskom i invalidskom osiguranju („Sl. list RCG”, br. 54/03, 39/04, 61/04, 79/04, 81/04, 14/07 i 47/07 i „Sl. list CG”, br. 79/08, 14/10, 78/10 i 34/11).

**AGRICULTURE****Agro-monetary statistics****Data sources**

Data about sales and buy out of products in agriculture, forestry and fishery are collected through monthly reports on realization of agricultural products of own production of agricultural enterprises and cooperatives and through monthly report on buying out of agricultural products from individual holdings.

**Coverage**

Monthly survey on sales and buying out of products in agriculture, forestry and fishing covers agricultural enterprises, agricultural cooperatives, as well as other enterprises authorized to do the buying out of products from individual holdings for future processing or sale.

Criteria for coverage of legal entities are number of workers (from 2 and more employed workers).

**Definitions**

Data on sales and buying out of products in agriculture, forestry and fishing cover the value of sale of products from own production of enterprises and cooperatives as well as the buying out of value of products from individual holdings, performed by authorized agencies for further processing or sale.

**Insured agricultural workers****Data source**

Official producers of data on insured agricultural workers is Department of Public Revenues. The data on insured agricultural workers are collected from current records kept by Pension and Disability Insurance Fund (for agricultural workers registered up to June 2004), and the register of Ministry of Agriculture and Rural Development (that keeps the Register of insured agricultural workers from 2004). An administrative data source is Department of Public Revenues. The termination of insurance for agricultural workers, that was registered up to June 2004 (in Pension and Disability Insurance Fund), is done by submitting form JPR, annex B, and act of Pension and Disability Insurance Fund on the termination of insurance by the side of insured person to the responsible regional office of Department of Public Revenues. Ministry of Agriculture, Forestry and Water Management submits the documentation on registration/termination of insured agricultural workers that are kept in its register.

**Definition of insured agricultural workers**

Insured agricultural workers are persons engaged in agricultural activity (agricultural workers, members of agricultural worker's household and members of mixed household) as one or main occupation that are not insured agricultural workers, insured persons engaged in independent activity, beneficiaries of pension, persons on education, and those persons with general health ability (Law on Pension and Disability Insurance (Official Gazette of the Republic of Montenegro 54/03, 39/04, 61/04, 79/04, 81/04, 14/07, and 47/07, and Official Gazette of Montenegro 79/08, 14/10, 78/10, and 34/11)
