

### Criteria for defining

### **OFFICIAL STATISTICS AND OTHER OFFICIAL STATISTICS PRODUCERS**

This act establishes definition and criteria of **official statistics**, as well as criteria for definition of **official statistics producer**, with the aim to determine which competent body produces 'official statistics' and fulfils the conditions to be defined as **other official statistics producer**.

#### **Definition of 'official statistics'**

**Official statistics** represent numerical and representative data and information on economic, demographic, and social phenomena as well as phenomena in domain of agriculture, labour, and environment, in line with regulations governing organization and affairs of official statistical system, as well as international statistical standards.

#### Criteria for defining 'official statistics'

- (i) Activities of official statistics are governed by <u>the</u> <u>Law on Official Statistics and Official Statistical</u> <u>System, Programme, and Plan of Official Statistics</u>;
- (ii) <u>Official statistics principles</u> defined by the Law on Official Statistics and Official Statistical System are respected and used in the production of official

#### Criteria for defining 'other official statistics producers'

- (i) Institution performs public authorities pursuant to the Law on State Administration and Decree on Organization and Manner of Work of State Administration, together with respecting criteria of official statistics.
- (ii) Activities on the production of official statistical data are governed by an appropriate main act (e.g. legislative act or secondary legislation, constitutive legal act, statute, statement, etc.) aimed at defining responsibility and competence for the production of specific or recognizable part of official statistics;
- (iii) Organizational unit, with staff member(s), is clearly defined for the production of official statistical data.

Official statistics producers are responsible for development, production, and dissemination of official statistics.

Referring to application of Article 8 and Article 9 paragraph 1 items 2, 3, and 4 of the Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12 and 47/19), and in line with the Eurostat's recommendations defined in the report on compliance with the European Statistics Code of Practice and role of national statistical institute, Statistical Office adopts the criteria for defining *official statistics* and *other official statistics' producers*.

# EXPLANATION

Normative framework for adopting the *Criteria for Defining 'official statistics' and 'other official statistics producers'* is:

# National:

  - Official statistical principles (Article 6);
  - Organization of official statistics system (Chapter III);

- Quality Declaration of Montenegro Statistical System;
- Quality Policy of Montenegro Statistical System;

- <u>Peer Review Report on compliance with the Code of Practice and the Coordination Role</u> <u>of National Statistical Institute</u> (Eurostat's recommendations), as it follows:
  - Recommendation 3.2.1 Strengthen coordination within the national statistical system;
    - Recommendation 3.2.1.1 Elaborate a clear definition of "official statistics" and criteria to qualify as 'other official statistics producer';
    - Recommendation 3.2.1.2 Reinforce quality management of other official statistics producers;
    - Recommendation 3.2.1.3 Improve visibility of other official statistics producers.

*The Law on Official Statistics and Official Statistical System* stipulates the legal framework for production and dissemination of official statistics, as well as the framework for organization of official statistics of Montenegro. The European Statistics Code of Practice has been implemented in Article 6 of this Law in which the principles related to the production of official statistics are defined.

Eurostat regularly assesses the alignment of official statistics producers with the official statistics principles (<u>Peer Review</u>). The assessment is based on the procedures of the European Statistical System and is intended for all EU member countries, as well as candidate countries and potential candidates.

One of the recommendations in the *Peer Review Report on Compliance with the Code of Practice and the Coordination Role of National Statistical Institute* is that Statistical Office to elaborate a clear definition of 'official statistics' aimed at the alignment with the European definition of official statistics.

The adoption of criteria for defining 'official statistics' implements the Eurostat's recommendations by which the alignment with the European Statistics Code of Practice is confirmed.

With the fulfilment of criteria for defining other official statistics producers, It enables interested institutions to be official statistics producers.
