## Arrivals and overnights of tourists, total

## 2022

In Montenegro, in 2022, tourists realised 2183975 arrivals and 12428787 overnights. Out of the total number of overnights, $95.5 \%$, were realized by foreign tourists, and $4.5 \%$ of overnights were realized by domestic tourists.

Concerning the structure of overnights of foreign tourists, in 2022, the most of them were realized by tourists from Serbia (25.5\%), Russian Federation (16.4\%), Bosnia and Herzegovina (9.9\%), Germany (5.9\%), Ukraine (4.9\%), Kosovo (4.0\%), and United Kingdom (3.3\%). Tourists from other countries were realised $30.1 \%$ overnights.

Concerning the structure of overnights by type of resort, in 2022, most of them were realised in seaside resorts (93.8\%), mountain resorts (2.0\%), capital (2.9\%), and other tourists resorts (1.3\%).

## METHODOLOGICAL NOTES

Survey on total tourist arrivals and overnight stays combines tourism traffic (arrivals and overnight stays) in the collective and in the individual / private accommodation.

Data on tourist traffic in collective accommodation (number of arrivals and overnight stays) have been collected by regular Monthly report on tourists arrivals and overnight stays in the collective accommodation establishments (form TU-11). Reports are made according to guest books which are led by receptions of collective accommodation establishments (all types of hotels, vacation facilities, boarding houses, motels, tourist resorts, hostels, etc.).

Since 2017 the methodology for calculating individual accommodation, in the process of data collection and processing, has included the following data sources: administrative databases (Local Tourism Organizations, Ministry of the Interior, Ministry of Sustainable Development and Tourism, National Tourism Organization, Secretariats of Local SelfGovernment) and statistical sources and records. The newly established administrative data sources are the result of new legislation, such as the register of residence registration (ie. Database RB90) under the jurisdiction of the Ministry of the Interior (regulated by the Law on Foreigners).

Non-registered tourists are not subject of this survey.
The aim of the survey on total arrivals and overnight stays is to provide basic information about the scope of traffic (arrivals and overnight stays) of domestic and foreign tourists.

The survey collects data on:

- Number of arrivals and overnight stays of domestic and foreign tourists in all accommodation establishments in Montenegro;
- Structure of arrivals and overnight stays of foreign tourists by country of residence in all accommodation establishments in Montenegro.

The survey covers all official data of catering establishments in the territory of Montenegro which provides accommodation services in houses and rooms for rent, as well as tourist apartments.

Tourist is a person who spends at least one night in an accommodation facility or some other object for accommodation of tourist, in a place other than his/her place of permanent residence for the reasons of rest or recreation, health, studies, sports, religion, family, business, public missions or meetings. Tourists do not include migrants, border workers, diplomats, member of military forces in the regular duty, refugees, etc.

Domestic tourist is a person with permanent residence in Montenegro who temporarily resides in any place of Montenegro, and spends at least one night in accommodation facility.

Foreign tourist is a person with permanent residence outside Montenegro, who temporarily resides in any place in Montenegro, and spends at least one night in an accommodation facility.

The data are published in line with the Statistical Release Calendar.

The last published data are considered preliminary, and become final within the defined deadline, as foreseen by the Statistical Release Calendar.

[^0]:    ${ }^{1}$ Total tourist arrivals and overnights include tourist arrivals and overnights in collective and individual, or so-called "private accommodation".Data on tourist traffic in collective accommodation are published on a monthly basis, and the direct source of data are collective accommodation facilities (all types of hotels, resorts, pensions, motels, tourist resorts, hostels, etc.).
    Data on tourist traffic in individual, so-called "private accommodation" is published annually, and the primary sources of information are data from Local Tourism Organizations in accordance with the Law on Tourist Organizations (Official Gazette of the Republic of Montenegro No 011/04 of 20.02.2004, 046/07 of 31.07. 2007, Official Gazette of Montenegro No. 073/10 of 10 December 2010, 040/11 of 08/08/2011, 045/14 of 24 October 2014, 042/17 of 30 June 2017, and 027/19 of 17 May 2019). Non-registered tourists are not the subject of survey.
