
Indices of industrial production and turnover

Fourth quarter 2023

Industrial production in Montenegro in IV quarter 2023 compared with IV quarter 2022 increased by 7,4%. At the sector level, compared to IV quarter 2022, Mining and quarrying increased by 8.0%, the Manufacturing increased by 4.0% and the Electricity, gas, steam and air conditioning supply increased by 11.5%.

Industrial production in Montenegro in IV quarter 2023 compared with III quarter 2023 increased by 21.0%. At the sector level, compared to III quarter 2023, Mining and quarrying decreased by 6.9%, the Manufacturing increased by 10.0%, while the Electricity, gas, steam and air conditioning supply increased by 48.1%.






- Quarterly index of production change in production in a current quarter compared with the previous quarter

Industrial turnover index in Montenegro in IV quarter 2023 increased 4.0% compared to IV quarter 2022, while increased 1.5% compared to III quarter 2023.

METHODOLOGICAL NOTES

Industrial production and turnover indices are one of the most important short-term indicators and a basis for decision making in the area of economy.

Industrial survey is harmonized with EU Regulation 1165/98 and Regulation 1502/2006 and the concepts and definition used in this survey are in line with these regulations. Survey provides the data on industrial production and turnover in industry.

Statistical Business Register (SBR) is used as the frame for the coverage for the purposes of this survey. Reporting units for industrial production indices are businesses engaged in the industrial production (sectors B, C, and D of Activity Classification), while for calculate industrial turnover indices are businesses engaged in the industrial production (sectors B and C of Activity Classification), as well as parts of commercial businesses classified into other sectors of Activity Classification, and they satisfy the criteria for this survey.

Quantities of finished products covered by sections B. C and D of Activity Classification are used for calculation of industrial production index-total. Turnovers in sections B and C of Activity Classification are used for calculation of industrial turnover index-total, in accordance with the mentioned EU Regulations.

Data are published according to the <u>Statistical Release</u> Calendar.

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
