# Industrial production (PRODCOM)

## 2023

This release presents the results of the annual survey of industrial production according to the statistical classification of industrial products-PRODCOM list in Montenegro in 2023.


Industrial products are defined by code, name and unit of measure from the PRODCOM list.

In 2023, significant products that recorded an increase in production compared to 2022 are:

- 23631000-Ready-mixed concrete for 27.9%;
- 07291300-Aluminum ores and concentrates for 19.1%;
- 11021231-Port, Madeira, sherry and other > 15 % alcohol for 18.0%;
- 10131120-Hams, shoulders and cuts thereof with bone in, for 14.8%.

In 2023, significant products that recorded a decrease in production compared to 2022 are:

- 20511150-Prepared explosives (excluding propellant powders) for -7.9%
- 28151030-Ball bearings for -8.6%;
- 23991310-Bituminous mixtures based on natural and artificial aggregate and bitumen or natural asphalt as a binder for -37.1%;
- 24421130-Unwrought non-alloy aluminum (excluding powders and flakes) for -49.6%.

### METHODOLOGICAL NOTES

Industrial production is one of the most important indicators and used as a basis for decision-making in the field of economy.

Industrial production survey is aligned with Regulation 3294/91 and the concepts and definitions prescribed by this regulation are applied, which ensures data comparability. It is conducted on a residential basis. Industrial production statistics are presented annually and are based on the statistical classification - PRODCOM list, which includes a large number of products.

The Statistical Business Register is used as a framework for inclusion in this survey. PRODCOM statistics include industrial production (with the exception of military products and some energy products) carried out by enterprises classified in sectors B, C and E of NACE Rev. 2, as well as parts of companies that are classified in other sectors of the Classification of Activities, and they satisfy the criteria provided for this survey

Data are published according to the <u>Statistical Release</u> <u>Calendar.</u>

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
