# Industrial production (PRODCOM)

## 2021

The production of more important industrial products in Montenegro in 2021 can be presented in different manners. Important industrial products are products classified in the area of Activity Classification with the largest share in the total industrial production.


In 2021, the production of the following products increased compared with the production from 2020:

- Coniferous wood; sawn or chipped lengthwise from 107 122 m<sup>3</sup> to 132 971 m<sup>3</sup>, i.e. 24.1%;
- Unwrought non-alloy aluminum from 37 208 t to 45 214 t, i.e. 21.5%;
- Ball bearings from 612 t to 776 t, i.e. 26.8%;
- Pre-coated aggregates from 191 122 t to 307 276 t, i.e. 60.8%;

In 2021, there was a decrease of production among the following products when compared with the production from 2020:

- Ready-mixed concrete from 703 539 t to 551 895 t, i.e. -21.6%;
- Aluminum ores and concentrates from 889 057 t to 542 049 t, i.e. -39.6%;
- Steel castings for machinery and mechanical appliances from 12 746 t to 2 913 t i.e. -77.1%;
- Ingots, other primary forms from 19 364 t to 3 042 t i.e. -84.3%.

#### **METHODOLOGICAL NOTES**

The survey of Industrial production (PRODCOM) is one of the most important indicators, and is used as a basis for decision making in the area of economy.

Industrial survey is harmonized with the EU Regulation No 3294/91, and the concepts and definition used in this survey are in line with this regulation. The survey provides data on industrial production and turnover in industry.

Statistical Business Register (SBR) is used as a frame for the coverage for the purposes of this survey. Reporting units for industrial production are businesses engaged in the industrial production (part of sector B and sector C of Activity Classification), as well as parts of commercial businesses classified into other sectors of Activity Classification, and they satisfy the criteria for this survey.

The data are published in line with the <u>Statistical</u> Release Calendar.

According to the Revision Policy of the Statistical Office, the final data shall be published on the date defined by the Statistical Release Calendar.
