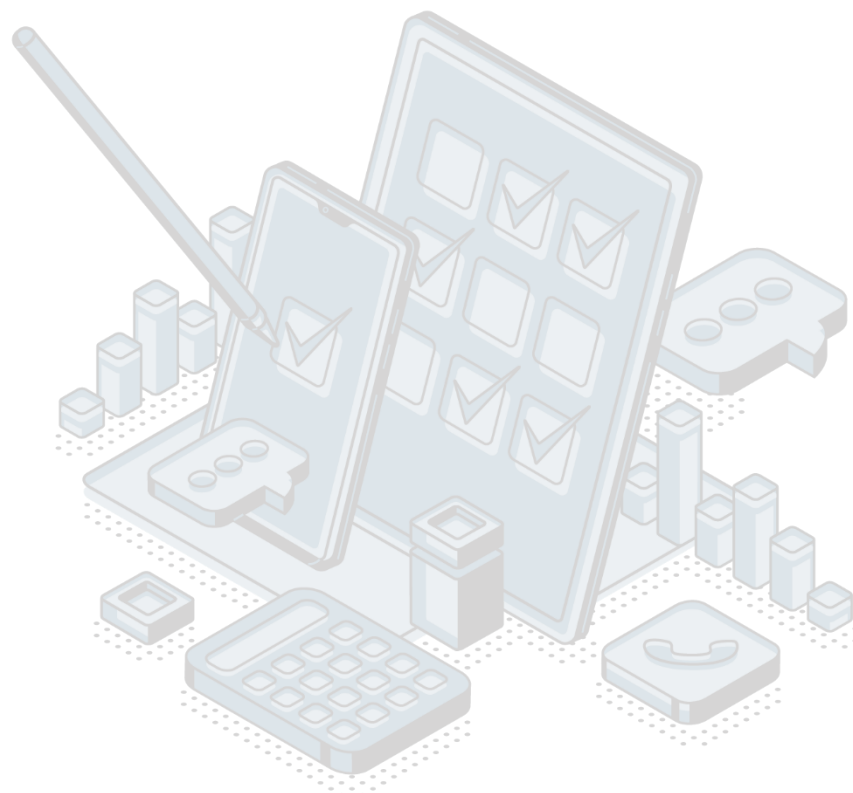

## 1. Introduction – Basic information about the survey

### 1.1 Purpose, goal and subject of the survey

Death statistics aim to produce data on the demographic and socio-economic characteristics of deaths. Based on these data, it is possible to monitor and study the total mortality of the population. The obtained data are needed for the analysis of the natural movement of the population at the level of Montenegro and municipalities. The data are also the basis for calculating a number of analytical demographic indicators that are used for the purpose of making analyses of either the current or future structure of the population. Death statistics cover all deaths entered in the Register of Deaths. In the processing, the data are grouped according to the residence of the deceased. Thus, the results of demographic statistics were processed according to the principle of place of permanent residence, which corresponds to the concept of permanent population applied in the census. Data are published at the municipal level and at the level of Montenegro.

### 1.2 Legal basis

The Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12, 47/19, 23/25) defines provisions for collection, processing and dissemination of data. The Law provides to the Statistical Office legal powers to collect and access the data necessary for the implementation of Programme and Annual Plan. The Law gives a priority to the use of administrative data and right of access to individual data that are a result of survey of other official statistical producers. As an annex to legal provisions, Statistical Office signed a Memorandum of Cooperation in the area of statistics on birth and death with the Ministry of the Interior, as the administrative source of data, in 2010.

#### 1.4.1 Sectors

All deceased persons recorded in the Register of Deaths of Ministry of Interior.

A deceased person is a person who died at any time after live birth. A deceased infant is every live-born child who died before reaching one year of age.

Data for 2025 are published on 14 April 2026 and submitted to Eurostat.

#### *Time lag of the first results*

Preliminary data shall be published no later than 60 (T + 60) days after the expiration of the reference period.

#### *Time lag of the final results*

Final results are published no later than 104 days after the expiration of the reference period (T + 104).

### 4.2 Punctuality of data publication

Data are published on the day defined by the Annual Plan and Statistical Releases Calendar. Indicator TP3 is 0, i.e. there is no difference between planned and actual announcement.

## 5. Availability and clarity

### 5.1 Statistical Release Calendar

The Law on Official Statistics and the System of Official Statistics ("Official Gazette of Montenegro" No 18/12, 47/19, 23/25) stipulates that producers of official statistics prepare, update and publish the Calendar of Publication of Statistical Data. It is published on the website of the Statistical Office no later than December 20 for the following year, for all producers of official statistics, which includes the dates of publication of statistical data. Any change in the date of publication in the Calendar shall be announced in advance in accordance with the Procedure for Unplanned Audits.

### 5.6 Availability of microdata

The Law on Official Statistics and Official Statistical System (Official Gazette of Montenegro No 18/12, 47/19, 23/25) regulates rules under which external users can obtain an access to individual data for needs of research. Article 58 defines types of scientific and research organizations that can obtain such data. Providing individual data without identifier is possible only upon a written request of scientific and research institutions, with purpose of performing scientific and research activities as well as international statistical organizations and statistical producers from other countries. Research entity signs the agreement with Statistical Office, and it signs the statement on respecting the confidentiality principle. Official statistical producers keep separate records on users and purpose of using the statistical data given to these users.
