## Preliminary results of the Census of Agriculture 2024

The Census of Agriculture was implemented in period from 1 October to 1 December 2024, in accordance with Law on the Census of Agriculture (Official Gazette of Montenegro No 77/2024 of 5 August 2024) and valid Regulations 2018/1091, 2018/1874, and 2021/2286 (EU) of the European Parliament and of the Council, and uniform standards of Food and Agricultural Organization of the United Nations (FAO).

Preliminary results of the census of agriculture comprises basic data on: number of holdings, holder of family agricultural holdings, utilised agricultural area, livestock, and machinery (tractors).


These data are subject to change until final results are released.

Having in mind that changes occurred in international and national legislative framework compared to the Census of Agriculture 2010, aimed at ensuring the data comparability, certain data recalculations were done in line with valid criteria from the census of agriculture, and in line with the EU criteria.

According to the preliminary results of the Census of Agriculture in 2024, the total number of agricultural holdings in Montenegro is 26 711. Agricultural holdings in 2024 utilised 248 234.2 hectares of agricultural area.

The total number of bovines in agricultural holdings was 68 600, sheep 167 344, goats 28 184, pigs 52 272, and poultry 1 361 403.

**Graph 1.** Number of agricultural holdings, by municipality









**Graph 3.** Number of sheep, by municipalities





**Graph 5.** Average age of holders, by municipality





## METHODOLOGICAL NOTES

### Data collection sources and methods

The Census of Agriculture was implemented from 1 October to 1 December 2024, in accordance with the [Methodological instructions](#). In preparation of the methodology on census of agriculture, there were applied international standards by which common rules are defined for collecting the data in agriculture:

- Regulation (EU) No 2018/1091 of the European Parliament and of the Council from 18 June 2018 on integrated farm statistics;
- Regulation (EU) No 2018/1874 of the European Parliament and of the Council from 29 November 2018;
- Regulation (EU) No 2021/2286 of the European Parliament and of the Council from 16 December 2021.

[The Law on the Census of Agriculture for 2024](#) envisaged preliminary census results to be published by Statistical Office within 90 days of the day of completed census.

Statistical data are considered to be preliminary (subject to changes during statistical data processing) until they are subject of regular revisions.

Final data will be published by Statistical Office, pursuant to the Annual Plan of Official Statistics and Statistical Release Calendar.

### Coverage

Census of Agriculture collects the data on number of agricultural holdings, area of utilised agricultural area by category of use, livestock by types and categories, persons participating in agricultural production by sex, livestock housing, machinery, equipment, etc.

On basis of available official statistics sources and administrative sources, Statistical Office has defined the address book (list of holdings) which is covered by the Census of Agriculture.

### Definitions

**Agricultural holding** is uniform, technical and economic unit which performs agricultural activity.

**Utilised agricultural area** comprises arable land, area under crops intended for the consumption of holding's members, orchards, vineyards, nurseries, meadows, and pastures.

**Family agricultural holding's holder** is a person who is owner or user (rents land for shorter or longer period) of family agricultural holding, i.e. person responsible for performing holding's agricultural activities.

**Livestock unit** is a standard measurement unit used for expressing aggregates or comparing numbers of different types and categories of animals.

Calculation of common land areas (mountain land, commune) used administrative sources, as well as the following formula:

### Area of utilised common land =

$$\begin{aligned} & ((\text{number of bovines} * \text{daily consumption of hay}) + \\ & (\text{No of sheep} * \text{daily consumption of hay}) + (\text{No of goats} * \\ & \text{daily consumption of hay}) + (\text{No of horses} * \text{daily} \\ & \text{consumption of hay})) * \text{No of days on common land} / \\ & \text{Average hay production from meadows} \end{aligned}$$

### Criteria

National criteria of the Census of Agriculture 2024 Agricultural holdings that meet at least one of the defined criteria: 5 000 m<sup>2</sup> of utilised agricultural area; 1 000 m<sup>2</sup> of arable land; 1 000 m<sup>2</sup> of aromatic, medicinal and culinary herbs, flower, ornamental plants, seeds and seedlings; 1 000 m<sup>2</sup> of fruit, berries, nuts, vineyards, olive trees, nurseries, and other permanent crops, 100 m<sup>2</sup> of greenhouses, 100 m<sup>2</sup> of mushrooms, 10 beehives, and 1 livestock unit.

### National criteria of the Census of Agriculture 2010

Agricultural holdings that used at least one of the defined criteria: 1 000 m<sup>2</sup> of agricultural land or less than 1 000 m<sup>2</sup> of agricultural area, and possessed: 1 cow and 1 calf or 1 cow and 1 heifer, or 1 cow and 1 adult head of small stock or 5 adult sheep or goats, or 1 adult pig, or 4 adult heads of sheep or goats or pigs together, or 50 heads of adult poultry, or 10 beehives. Exceptions were households not fulfilling the above-mentioned conditions, if the agricultural production was their only source of income, as well as households engaged only in the cultivation of mushrooms in special buildings (cellars, tunnels).

**EU criteria** – Agricultural holdings that meet at least one of defined criteria: 5 ha of utilised agricultural area, 2 ha of arable land; 5 000 m<sup>2</sup> of potato, 5 000 m<sup>2</sup> of fresh vegetable and strawberry, 2 000 m<sup>2</sup> of aromatic, medicinal and culinary herbs, flowers, ornamental plants, seeds and seedlings; 3 000 m<sup>2</sup> of fruit, berries, nuts, vineyards, olive trees, nurseries, and other permanent crops; 1 000 m<sup>2</sup> of vineyard, 3 000 m<sup>2</sup> of olive trees, 100 m<sup>2</sup> of greenhouses, 100 m<sup>2</sup> of mushrooms, and 1.7 livestock unit.
