Turnover index in services

First quarter 2026

The services turnover index in the first quarter of 2026, compared to the first quarter of 2025, increased by 0.8%.

The turnover index in services in sector G - Wholesale and retail trade of motor vehicles and motorcycles, and wholesale in the first quarter of 2026, compared to the first quarter of 2025, increased by 0.7%.

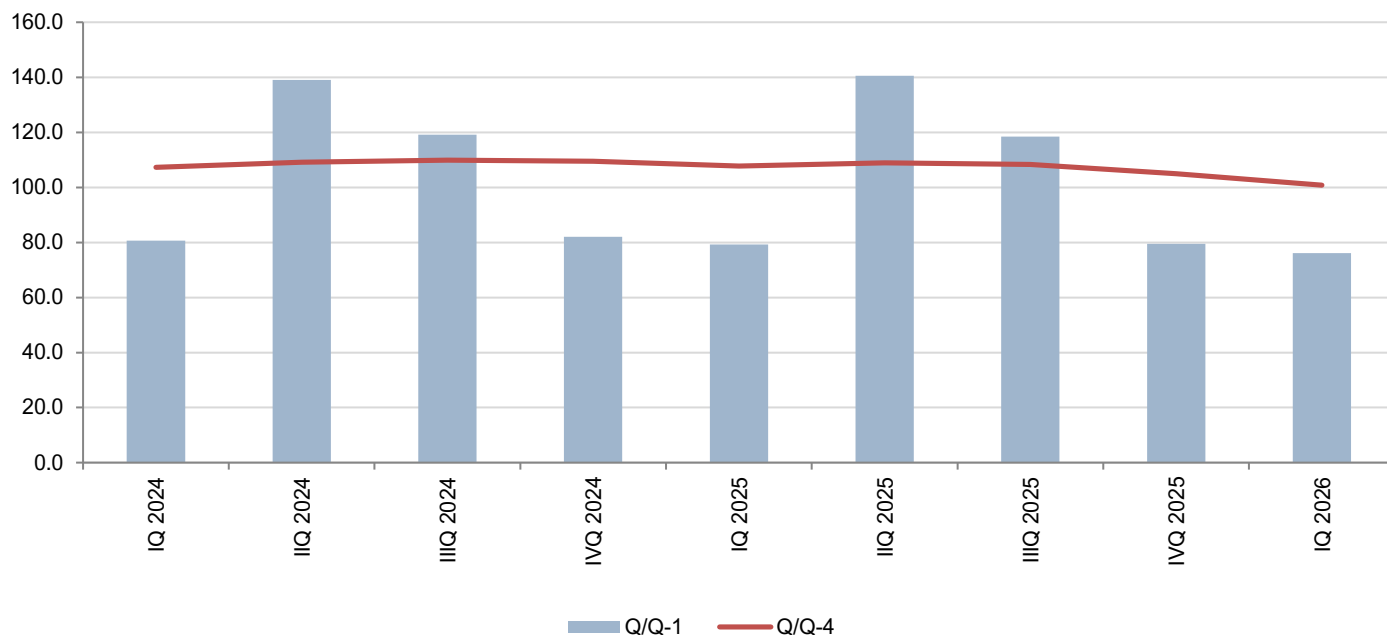
The turnover index in services in sector H - Transport and storage in the first quarter of 2026, compared to the first quarter of 2025, decreased by 5.9%.

The turnover index in services in sector I - Accommodation and food services in the first quarter of 2026, compared to the first quarter of 2025, increased by 9.0%.

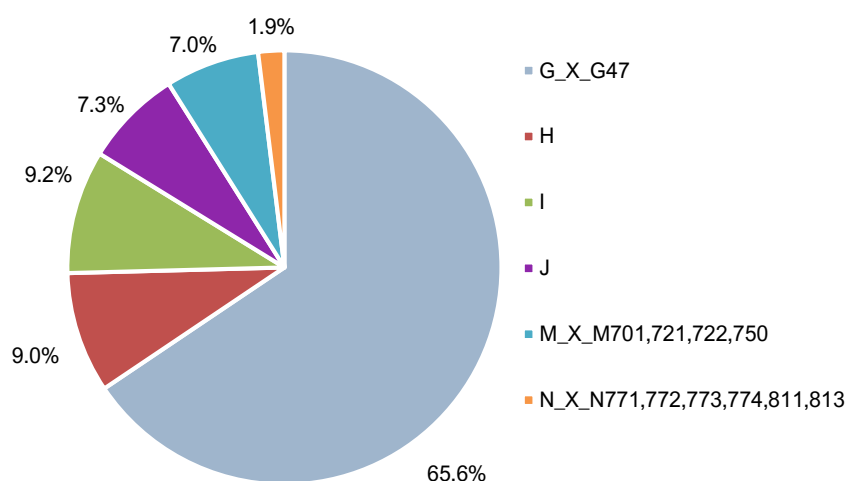
The turnover index in services in sector J - Information and communication in the first quarter of 2026, compared to the first quarter of 2025, decreased by 1.0%.

The largest share in the total turnover of service activities in the first quarter of 2026 is achieved in the Wholesale and retail trade of motor vehicles and wholesale (65.6%), while the lowest in the group of activities was Administrative and support service activities (1.9%).

METHODOLOGICAL NOTES

The survey aims to measure the dynamics of turnover in service activities. The dynamics of turnover are shown through index numbers.

Turnover includes the monetary value of services performed or provided on the market in the reporting quarter, excluding value-added tax.

The data source for implementing the Turnover index in services is turnover data from VAT returns under the jurisdiction of the Tax Administration, with the balance as of July 22, 2026.

The coverage is based on EU Regulation 2019/2152 on short-term statistics, including its amendments, and is fully aligned with its concepts and definitions.

All active companies that have submitted a VAT return to the competent authority are covered, as are parts of business companies (KAU) that engage in service activities.

Total turnover in service activities refers to companies whose main activities are in the field of services listed in Table 2.

Data are published according to the [Statistical Release Calendar](#).

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
