Average earnings (wages)

January 2024

The average earnings (gross) in Montenegro in January 2024 are 1 024 Euro, while the average earnings without taxes and contributions (net) are 819 Euro. The average earnings without taxes and contributions (net) in January 2024 comparing to December 2023 increased for 0.6%, while the average earnings without taxes and contributions (net) in January 2024 comparing to the same month of the previous year increased for 8.2%.

Having in mind that consumer prices in January 2024 comparing to December 2023 increased for 0.5% the results is that real earnings without taxes and contributions (net) in the same period increased for 0.1%.

Graph 1. Average earnings without taxes and contributions (net) in EUR

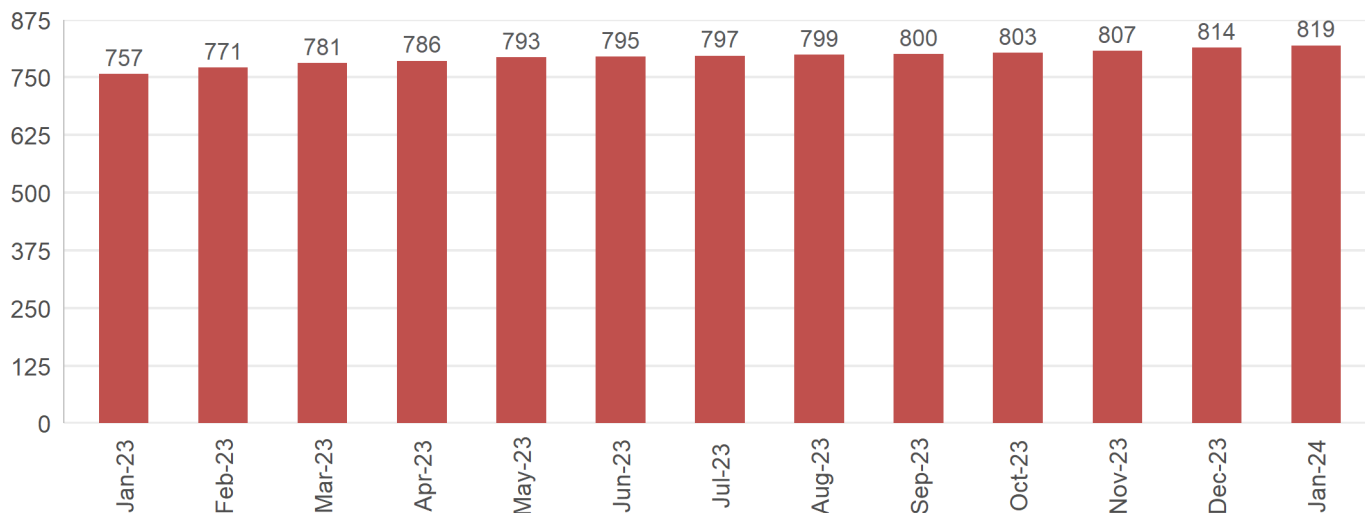

At the sector level, the average earnings without taxes and contributions (net) in January 2024 compared to December 2023 increased in the following sectors: Water supply, sewerage, waste management and remediation activities (4.4%), Other service activities (3.9%), Manufacturing (3.2%), Wholesale and retail trade and repair of motor vehicles and motorcycles (3.0%), Real estate activities (2.9%), Professional, scientific and technical activities (1.5%), Human health and social work activities (1.1%), Accommodation and food service activities (0.7%), Administrative and support service activities (0.3%), Information and communication (0.2%) and Transportation and storage (0.1%).

There were a decrease in the following sectors: Construction (3.3%), Public administration and defence; compulsory social security (1.1%), Financial and insurance activities (0.9%), Electricity, gas, steam and air conditioning supply (0.8%), Education (0.4%), Mining and quarrying (0.3%), Agriculture, forestry and fishing (0.1%) and Arts, entertainment and recreation (0.1%).

METHODOLOGICAL NOTES

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD-1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index.
