Average earnings (wages)

December 2024

The average earnings (gross) in Montenegro in December 2024 are 1 205 euro, while the average earnings without taxes and contributions (net) are 1 012 euro. The average earnings without taxes and contributions (net) in December 2024 comparing to November 2024 increased for 1.9%, while the average earnings without taxes and contributions (net) in December 2024 comparing to the same month of the previous year increased for 24.3%.

Having in mind that consumer prices in December 2024 comparing to November 2024 decreased for 0.1% the results is that real earnings without taxes and contributions (net) in the same period increased for 2%.

At the level of 2024 average gross earnings were 1 083 euro while the average net earnings were 876 euro. Having in mind that consumer prices in 2024 comparing to 2023 increased 3.3%, the results is that real earnings without taxes and contributions (net) in the same period increased 7.1%.

Graph 1. Average earnings without taxes and contributions (net) in EUR



At the sector level, the average earnings without taxes and contributions (net) in December 2024 compared to November 2024 increased in the following sectors: Administrative and support service activities (10.4%), Real estate activities (9.3%), Water supply, sewerage, waste management and remediation activities (6.6%), Public administration and defence; compulsory social security (4.5%), Wholesale and retail trade and repair of motor vehicles and motorcycles (4.1%), Arts, entertainment and recreation (3.8%), Agriculture, forestry and fishing (3.5%), Professional, scientific and technical activities (3.3%), Other service activities (2.8%), Accommodation and food service activities (2.4%), Transportation and storage (2.2%), Manufacturing (1.4%), Information and communication (0.7%), Education (0.3%), Mining and quarrying (0.2%) and Electricity, gas, steam and air conditioning supply (0.1%).

There was a decrease in the following sectors: Financial and insurance activities (11.6%), Construction (2.9%), and Human health and social work activities (1.1%).

METHODOLOGICAL NOTES

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD-1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index. When using data please name the source: "Data source: Statistical Office of Montenegro"
