

Average earnings (wages)

April 2025

The average earnings (gross) in Montenegro in April 2025 are 1 202 euro, while the average earnings without taxes and contributions (net) are 1 009 euro. The average earnings without taxes and contributions (net) in April 2025 comparing to March 2025 increased for 0.6%, while the average earnings without taxes and contributions (net) in April 2025 comparing to the same month of the previous year increased for 21.9%.

Having in mind that consumer prices in April 2025 comparing to March 2025 increased for 0.8%, the results is that real earnings without taxes and contributions (net) in the same period decreased for 0.2%.





At the sector level, the average earnings without taxes and contributions (net) in April 2025 compared to March 2025 increased in the following sectors: Arts, entertainment and recreation (2.7%); Human health and social work activities (2.5%); Wholesale and retail trade and repair of motor vehicles and motorcycles (1.9%); Public administration and defence: compulsory social security (1.8%); Manufacturing (1.2%); Accommodation and food service activities (1.2%); Electricity, gas, steam and air conditioning supply (1.1%); Construction (1.1%); Mining and quarrying (0.4%); Education (0.3%), and Agriculture, forestry and fishing (0.2%).

There was a decrease in the following sectors: Information and communication (5.2%); Real estate acitivities (4.9%); Financial and insurance activities (2.8%); Transportation and storage (1.5%); Water supply, sewerage, waste management and remediation activities (0.8%); Professional, scientific and technical activities (0.5%); Other service activities (0.2%), and Administrative and support service activities (0.1%).

METHODOLOGICAL NOTES

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD-1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index. When using data please name the source: "Data source: Statistical Office of Montenegro"
