

## Average earnings (wages)

## May 2025

The average earnings (gross) in Montenegro in May 2025 are 1 208 Euro, while the average earnings without taxes and contributions (net) are 1 014 Euro. The average earnings without taxes and contributions (net) in May 2025 comparing to April 2025 increased for 0.5%, while the average earnings without taxes and contributions (net) in May 2025 comparing to the same month of the previous year increased for 21.9%.

Having in mind that consumer prices in May 2025 comparing to April 2025 increased for 0.6% the results is that real earnings without taxes and contributions (net) in the same period decreased for 0.1%.

At the sector level, the average earnings without taxes and contributions (net) in May 2025 compared to April 2025 increased in the following sectors: Agriculture, forestry and fishing (3.1%), Other service activities (1.4%), Manufacturing (1.2%), Accommodation and food service activities (1.2%), Water supply, sewerage, waste management and remediation activities (1.1%), Wholesale and retail trade and repair of motor vehicles and motorcycles (1.0%), Arts, entertainment and recreation (0.9%), Mining and quarrying (0.8%), Professional, scientific and technical activities (0.8%), Administrative and support service activities (0.8%), Human health and social work activities (0.8%), Transportation and storage (0.6%), Public administration and defence; compulsory social security (0.5%), Construction (0.1%), and Information and communication (0.1%).

There was a decrease in the following sectors: Real estate activities (6.7%), Financial and insurance activities (1.4%), Education (0.3%), and Electricity, gas, steam and air conditioning supply (0.1%).

## **METHODOLOGICAL NOTES**

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD-1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index.
