Average earnings (wages)

June 2025

The average earnings (gross) in Montenegro in June 2025 are 1 203 Euro, while the average earnings without taxes and contributions (net) are 1 010 Euro. The average earnings without taxes and contributions (net) in June 2025 comparing to May 2025 decreased for 0.4%, while the average earnings without taxes and contributions (net) in June 2025 comparing to the same month of the previous year increased for 20.5%.

Having in mind that consumer prices in June 2025 comparing to May 2025 increased for 0.4% the results is that real earnings without taxes and contributions (net) in the same period decreased for 0.8%.





At the sector level, the average earnings without taxes and contributions (net) in June 2025 compared to May 2025 increased in the following sectors: Agriculture, forestry and fishing (2.4%), Transportation and storage (1.3%), Electricity, gas, steam and air conditioning supply (1.2%), Professional, scientific and technical activities (1.2%), Water supply, sewerage, waste management and remediation activities (1.1%), Financial and insurance activities (1.1%), Other service activities (0.8%), Public administration and defence; compulsory social security (0.5%) and Wholesale and retail trade and repair of motor vehicles and motorcycles (0.2%).

There was a decrease in the following sectors: Accommodation and food service activities (4.9%), Construction (2.4%), Real estate activities (1.8%), Mining and quarrying (1.4%), Education (1.2%), Information and communication (1.0%), Arts, entertainment and recreation (1.0%), Human health and social work activities (0.7%), Administrative and support service activities (0.5%) and Manufacturing (0.2%).

METHODOLOGICAL NOTES

The data on average monthly earnings present earnings paid within a month, and they are received by the regular monthly survey Monthly report on employees and earnings (RAD-1 form).

The average earnings (gross) are calculated dividing the total earnings paid off in a month by the number of number of employees the paid earnings refer to. Earnings without taxes and contributions (net) comprise earnings (gross) reduced by taxes and contributions paid by employee.

The index on real average earnings without taxes and contributions (net) represent the ratio between index on nominal average earnings without taxes and contributions (net), and consumer price index.
