

The service turnover index¹ in the first quarter of 2019 compared to the same quarter of the previous year increased by 6.0% in current prices.




Graph 1. Turnover index in other services

The largest share in the total turnover of service activities in the first quarter of 2019 is achieved in the wholesale and retail trade of motor vehicles aggregate (63.0%), while the lowest one is in the administrative and auxiliary service activities' aggregate (2.4%).

METHODOLOGICAL NOTES

Data source and coverage

Statistical Office of Montenegro conducts a quarterly survey of the Turnover Index in Services from Administrative Source (Department of Public Revenues) since January 2018.

The coverage is based on the EU Regulation No 1165/98 for short-term statistics (Appendix D) and on its amendments. The survey is fully in line with the concepts and definitions from the mentioned Regulation. Total turnover in service activities includes turnover from the list of activities provided in Table 2, and it covers all companies in Montenegro that have reported VAT registration to the Tax Administration of Montenegro.

The main purpose of the survey is to measure the dynamics of turnover in service activities. The dynamics of turnover is shown through index numbers.

From 2014 to 2018, Statistical Office of Montenegro carried out a quarterly survey based on a stratified sample and reporting method. The data of this survey are published at the level of the following activities: G45, G46, H, I, J, K, L, M, N, P, Q, R, S.

Definitions

The turnover covers a monetary value of performed, rendered services on the market in the reporting quarter. The value added tax is excluded from the turnover.

According to the Revision policy of the Statistical Office, the final data shall be published with the date defined by the Statistical Release Calendar.
