

## INVESTICIJE

### Izvori i metodi prikupljanja podataka

Podaci o ostvarenim i isplaćenim investicijama prikupljaju se Godišnjim izvještajem o investicijama u osnovna sredstva (INV – 01) od pravnih lica u zemlji ako su neposredni investitor.

Obrazac INV-01je od 2006god djelimično izmijenjen i usaglшен sa međunarodnim statističkim standardima i metodologijama, tj sa Evropskim sistemom računa 1995(ESA95) i Sistemom nacionalnih računa 1993(SNA93).

Investicije privatnog sektora bez pravnih lica (investicije fizičkih lica) prikuplju se na bazi posebnog uputstva Zavoda za statistiku a korišćenjem raspoloživih podataka iz postojećih statističkih istraživanja.

### Obuhvatnost

Cilj ovog istraživanja je da podaci o investicionoj aktivnosti u zemlji omoguće obračun BDP prema potrošnoj metodi, utvrdi učešće bruto investicija u BDP. Godišnjim izvještajima o investicijama u osnovna sredstva (obrazac INV-01) u tekućim cijenama obuhvaćena su pravna lica, ukoliko su neposredni investitori, bez obzira da li su u redovnom ili probnom radu, izgradnji ili likvidaciji. Kriterijum za obuhvat pravnih lica je broj radnika (od pet i više).

Do 2010.god. pri prikupljanju i objavljivanju u službenoj primjeni bila je Klasifikacija djelatnosti NACE .Rev .1.1.a od 2011.god. Klasifikacija djelatnosti NACE.Rev.2.Podaci za 2009 i 2010.god. obrađeni su po Klasifikaciji djelatnosti NACE rev.2 na nivou sektora.Podaci su grupisani po djelatnostima i teritoriji: a) prema pretežnoj djelatnosti i sjedištu izvještajne jedinice investitora tzv.organizacioni princip i b) po namjeni i lokaciji investicija tzv. princip čistih djelatnosti. Ostvarene investicije privatnog sektora bez pravnih osoba (fizičkih osoba) rezultat su procjene Zavoda za statistiku i obuhvataju ulaganja u stambenu gradnju građana i individualnu poljoprivredu..

### Definicije

*Investicijama u osnovna sredstva* se smatraju nabavke ostvarene od strane preduzeća i drugih organizacija i zajednica u cilju dobijanja novih, povećanja vrijednosti ili zamjene postojećih osnovnih sredstava i stambenih zgrada. Nabavljena investiciona dobra mogu biti nova ili već korišćena, kupljena ili dobijena bez naknade od drugih u zemlji i inostranstvu, ili proizvedena u sopstvenoj režiji. Obuhvataju se pri tom sve vrste ulaganja u nove kapacitete, kao i za proširenja, dogradnju, rekonstrukciju i modernizaciju postojećih ili zamjenu zastarjelih, istrošenih ili slučajnom štetom uništenih kapaciteta. Investicijama se ne obuhvataju sredstva utrošena za investiciono i redovno održavanje postojećih objekata.

*Ispłata za investicije* smatraju se novčana ulaganja u toku godine u kojoj su isplate stvarno izvršene, bez obzira na momenat njihove izgradnje ili nabavke.

*Ostvarene investicije* u toku izvještajne godine predstavljaju vrijednost efektivno izvršene izgradnje, izrade ili nabavke objekata, opreme i ostalog, bez obzira da li su završene i da li je njihova isplata izvršena (bez revalorizacije ostvarenih investicija).

## INVESTMENTS

### Sources and methods of data collection

The data on realised and paid investments of legal entities are collected through annual survey on investments into fixed capital (questionnaires INV-01) from legal persons in Montenegro that are direct investors.

Since 2006 the INV-01 form has been partly changed and harmonised with the international statistical standards and methodologies, i.e. with the European System of Accounts 1995 (ESA95), and the System of National Accounts (SNA93).

The data on investments of private sector without legal persons (investments of natural persons) are collected in accordance with special instructions of Statistical Office of Montenegro on the basis of available data from other statistical surveys.

### Coverage

The aim of this survey is with the data on investment activities in the country to enable the GDP calculation by expenditure approach, and to assess the share of gross investment in GDP. All legal persons have been covered by the annual survey on investments in fixed capital (questionnaire INV-01) at current prices, if they are direct investors, and whether they are in regular or probation work, under construction or liquidation process. Number of workers (five and over) is a criterion for the coverage of legal persons.

Until 2010 the activity classification NACE Rev. 1.1 was officially used, and since 2011 the activity classification NACE Rev.2 is in use. The data for 2009 and 2010 are processed in accordance with the NACE Rev.2 at the sector level. The data are sorted by activities and territory: a) by main activity and investor's main office (so-called organizational principle"), and b) by investment purpose and location, (the "principle of pure activities"). The actual investments of private sector without legal persons (natural persons) are the result of MONSTAT estimations, and they include investments in housing construction and individual agricultural business.

### Definitions

*Investments into fixed capital* are purchases made by enterprises and other organizations and associations in order to obtain new assets, increase the value of existing assets or replace them. Acquired investment goods can be new or already used, purchased or received with no compensation from others in country and abroad, or self-produced. All investments into new facilities are included, as well as investments for capacity extensions, re-building and modernization of existing facilities or replacement of old ones, ruined or destroyed by accident. Investments do not cover investment expenditures and regular maintenance of existing infrastructure.

*Payments for investments* are investments in cash during a reference year in which payments were actually made regardless the time of construction or purchase.

*Realized investment* during the reference year is the value of actual construction, building or procurement of facilities, equipment etc., regardless of whether they are completed or not and payment made (without revaluation of realized investment).

Podaci o ostvarenim investicijama u nova osnovna sredstva odnosi se na onaj dio osnovnih sredstava koji je nabavljen neposredno od izvođača građevinskih radova, proizvođača opreme ili proizведен u sopstvenoj režiji, odnosno osnovna sredstva koja još nijesu bila predmet kupoprodaje između neposrednih korisnika tih dobara. Ovdje se uključuje i polovna oprema nabavljena u inostranstvu budući da direktno utiče na porast društvenog bogastva zemlje. U nabavku novih osnovnih sredstava razvrstane su i investicije u značajnija poboljšanja postojećih sredstava kao i investicija u značajnija poboljšanja zemljišta. Takođe se uključuju i investicije u rekonstrukcije modernizacije, dogradnju i proširenje za preuzređenje ili proširenje postojećih objekata, opreme i uređaja, u cilju proširenja obima, boljeg prilagodavanja potrebama tržišta, tehničko-tehnološkim rješenjima ili usluga.

**U investicije za građevinske objekte** uključuju se i vrijednost opreme koja je ugrađena u građevinske objekte (liftovi, uređaji za grijanja i sl. i projekti za njih).

**Investicije u opremu** obuhvataju i troškove montaže, prevoza, carine i osiguranja.

**Investicije u ostalo** prikazuju ulaganja u osnovno stado, posumljavanje, rudarska istraživanja, softveri, licence i dr.

The data on realized investments in new fixed assets refer to the fixed assets directly purchased from the builder contractor, producers of equipment or to those produced on their own, that is the assets that were not bought or sold earlier. Here, we also include the used equipment purchased abroad since it has a direct impact to the growth of national wealth. Both, the investments in significant improvements of existing fixed assets and investments in significant improvements of land area are also considered as the purchase of new fixed assets. Moreover, investments in reconstructions, modernization, adding on or enlargement of existing facilities, equipment and machines for the purpose of further development, better adjustments to the market needs, technical-technological solutions or services.

**Investments in buildings** include also the value of the integral equipment mounted or built in (elevators, heating systems and similar as well as associated project)

**Investments in equipments** include also the costs of their mounting, transport, customs duties and insurance.

**Other investments** include investments in the principle herd, afforestation, mining explorations, software, licences etc.
