

## OSTALE USLUGE

### Izvori podataka i metode prikupljanja podataka

Izvor podataka za statistiku ostalih usluga je administrativni - Poreska uprava Crne Gore (podaci o prometu na osnovu PDV prajava). Jedinice posmatranja su sva preduzeća (privredna društva) u Crnoj Gori koja su predala PDV prijavu Poreskoj upravi Crne Gore.

### Obuhvat

Obuhvat se temelji na Regulativi EU br. 1165/98 za kratkoročne statistike (Dodatak D) i njenim izmjenama i dopunama. Ukupan promet u uslužnim djelatnostima obuhvata promet u sljedećim djelatnostima Klasifikacije djelatnosti (KD 2010): G\_X\_G47 - Trgovini na veliko i malo motornim vozilima i motociklima (bez oblasti G47 Trgovina na malo); H - Saobraćaj i skladištenje; I - Usluge smještaja i ishrane; J - Informisanje i komunikacije; M\_X\_M701,721,722,750 - Stručne, naučne i tehničke djelatnosti (bez grana M701, M721, M722 i M750); N\_X\_N771,772,773,774,811,813 - Administrativne i pomoćne uslužne djelatnosti (bez grana N771, N772, N773, N774, N811, N813).

### Definicije

Promet robe bez PDV-a je vrijednost ukupnog prometa koji je preduzeće ostvarilo u toku izvještajnog kvartala na teritoriji Crne Gore i iskazuje se u eurima. Obuhvata se ukupan promet koji je preduzeće ostvarilo, bez obzira da li je ostvaren u nekoj drugoj djelatnosti. Obrađuje se vrijednost prometa bez PDV-a u izvještajnom kvartalu.

PDV je vrijednost poreza na dodatu vrijednost koji je obračunat kupcu.

Klasifikacija djelatnosti (KD2010) je klasifikacija svih ekonomskih djelatnosti koje se mogu obavljati na teritoriji CrneGore i koristi se za prikupljanje, upisivanje, obradu, objavu i diseminaciju statističkih podataka. Takođe, klasifikacija se koristi i za razvrstavanje privrednih subjekata (pravnih i fizičkih lica), kao i za vođenje poslovnih registara.

## OTHER SERVICES

### Sources and methods of data collection

The source of data for the statistics of other services is administrative - Department of Public Revenues (data on turnover based on VAT declaration).The units of observation are all companies (companies) in Montenegro who submitted VAT registration to the Department of Public Revenues of Montenegro.

### Coverage

Coverage is based on EU Regulation no. 1165/98 for short-term statistics (Appendix D) and its amendments. Total turnover in service activities includes turnover in the following activities Classification of Activities (KD 2010): G\_X\_G47 - Wholesale and retail trade in motor vehicles and motorcycles (excluding G47 Retail); H - Traffic and storage; I - Accommodation and food services; J - Information and communication; M\_X\_M701,721,722,750 - Professional, scientific and technical activities (without branches M701, M721, M722 and M750); N\_X\_N771,772,773,774,811,813 - Administrative and support service activities (without branches N771, N772, N773, N774, N811, N813).

### Definitions

The turnover of goods without VAT is the value of the total turnover that the company realized during the reporting quarter in the territory of Montenegro and is presented in euros. It covers the total turnover that the company has achieved, regardless of whether it has been realized in any other activity. Value of turnover without VAT in the reporting quarter is processed.

VAT is the value of the value added tax that is calculated by the buyer.

Classification of Activities (KD2010) is a classification of all economic activities that can be performed on the territory of Montenegro and is used for collecting, entering, processing, publishing and disseminating statistical data. Also, the classification is used for the classification of business entities (legal entities and natural persons), as well as for keeping business registers.
